CUPE Local 3906 Executive Nomination Form Instructions

CUPE Local 3906 Executive Elections are governed by the CUPE National Constitution (available here: <https://cupe.ca/cupe-constitution>) and the Local's Bylaws (available here: <https://cupe3906.org/about-us/by-laws/>).

Terminology:

Nominator: a CUPE 3906 Member who officially suggests a candidate for an election.

Nominee: a CUPE 3906 Member who is formally proposed as a candidate for an elected office or position.

CUPE 3906 Member: someone who is currently working in (a) position(s) covered by the CUPE 3906 Collective Agreements or has worked in (a) position(s) covered by the CUPE 3906 Collective Agreements within the previous two (2) academic terms. (Please note: the Spring/Summer Term counts as one term.)

Unit 1: McMaster University Employee working as a Teaching Assistant or Research Assistant (in Lieu of Teaching Assistant)

Unit 2: McMaster University Employee working as a Sessional Faculty or Hourly Rated Sessional Music Faculty (excluding those working in Health Sciences)

Unit 3: McMaster University Employee working as a Postdoctoral Fellow (excluding those working in Health Sciences)

Unit 4: McMaster University Employee working as a Residence Life worker, including Community Advisors (CAs), Guest Registration Assistants (GRAs), Project Assistants (PAs), Graduate Community Leaders (GCLs), and Residence Orientation Planners and Assistants (ROP/As), and other positions below the rank of Residence Life Area Coordinator (RLAC).
