Mary Ellen: The annual conference is later this month. We should have a decent report from that at the next GMM I'd suspect.

xiv. CUPE Council

Rand: Moving into the election, it is important that we band together in labour. If you're interested in coming to this, anyone is welcome. If you're interested in organizing larger labour efforts in Hamilton, this will be a good opportunity. Free food as well!

11. Nomination, elections, or installations

Mary Ellen chaired

a. 5 CUPE Ontario Conference Delegates

Mary Ellen: This conference happens every year. According to the way the union is set up, we have an affiliation with CUPE Ontario.

Brad: It is taking place May 28-31 in Toronto.

Mary Ellen: We have 5 delegate positions. The expectation is that you attend as much as possible and vote on motions. You can be a member of any unit to go. If you're staying in Toronto, the local will pay for your fees.

Mitch: Can't we have more than 5?

Mason: We can do more than 5, but this is our usual number.

Ori: The goal is to represent the views of the local as much as possible. Is it mandatory for the delegates to vote exactly how the local should?

Mary Ellen: Not mandatory, more that people are meant to be representing the local and the positions the local has taken. There are situations where that's not totally clear; it won't be policed, but to the best of your ability, you should do so.

Bonnie: Myself and many others may be going to CAWLS that weekend -- is there any partial fee or barring folks from coming for most but not all of the conference?

Mary Ellen: Nothing prevents someone from doing both, but if it comes to an election, it's good to mention that.

Mary Ellen opens the floor for nominations.

Mary Ellen: We'll give folks a 2-min talking period about why they should be elected. We are going in reverse order starting with Ori.

Ori: I'd like a minute.

Mary Ellen: No, we are going in reverse order so it is you up first.

Ori: I think it's reasonable to ask for time to prepare.

Mary Ellen: Enrique are you ready to go?

Speeches:

Enrique: Sure. I would like to be elected; I attended previously last year, and I think I have a bit of experience on what sort of things the local is prioritizing. I think that as I have previous experience, that would be useful this time. Thanks for your attention.

Mitchell: I'm a steward from the labour studies department and a representative at the HDLC. I have never been but would be honoured to go and represent everyone. Thanks!

Bonnie: I also have not gone yet but I think it's a crucial year to build labour power and connect with other CUPE locals in Ontario. I may be gone for a half day for CAWLS. I also live in Toronto so no need to pay for my hotel fees!

Caleb: I would love the opportunity to attend. I have never been as a delegate but I attended as a visitor last year. It was great to form connections between our local and others. Also I think it is so important to have someone from unit 4 attend and connect with more locals.

Rand: It has been a goal of mine to build connections in the local and between other locals. I've done this through running socials and CUPE council. It is in my purview to go to this conference and keep building connections. We need large scale group organizing, and I'd love to organize the post-secondary sector. Also will be staying in Toronto!

Mason: I went to the last one and managed to get a resolution passed to commit CUPE national to hiring more organizers after the experience of organizing unit 4. I'm going to bring another motion to ask this but also to hire more member organizers. That is, not full time organizers, but members also doing organizing work. It'll be good to get our word out. No need to get hotel for me, I'm staying in Toronto and/or Hamilton. I'll also be at CAWLS.

Ori: Thanks for the time. I'm a member of unit 3. Beyond being happy to go, I have good priorities to divert money to labour issues. Attending the Ontario conference is an opportunity to voice our perspectives. We can strategize about our rights. I will represent all units and will ensure priorities of CUPE 3906 will give us better working conditions.

Brad: If you'll recall last GMM, we approved bylaws changes on elections. The election will be held online. You'll get a ballot sometime later today. They'll be available for 72 hours after being sent. People who registered for the GMM will be eligible to vote. We'll meet after this period with staff, local rep, and scrutineer(s) to review the votes. Under the terms of our bylaws, we require people to get a 50% majority. If we don't fill all the people, there will be a subsequent election, etc. until we have majority support. 7 people are contesting the election, you will have to vote for 5.

Mary Ellen: Make sure to check your spam folder, let us know if you don't receive a ballot. Every candidate can name a scrutineer; it just can't be you. If we don't have several scrutineers, we should just get volunteers. Would any candidate like to name a scrutineer?

Brad: If people don't appoint scrutineers, one will be appointed. It takes like 15 minutes max. Shows an anonymized number of votes. If you're not on exec and have 10-15 minutes to spare, we'd very much appreciate it. You don't have to do much other than making sure the results we share are the ones you saw.

Mary Ellen: You can do it remotely.

Kusum: If it's just 10 minutes, I can do that.

Mary Ellen: Thank you! If anyone else wants to volunteer, let me know.

Brad: I'll email folks; it would be good to have more scrutineers.

b. 2 Trustees (1-year and 3-year)

Mary Ellen: No one stepped forward at the last GMM, so the bylaws say that this re-appears again on the agenda until we can fill it.

Mary Ellen reads from <u>Article 3a in our bylaws</u> about Trustee duties.

Brad: These are positions that participate in an annual audit of the local's finances. We've had to push it back. One trustee will just do this audit. The other would do this in a 3-year term and participate in 3 audits. Of course, if you graduate, you can resign the position. Audits take about a day. Usually on weekends, with the treasurer and 3 trustees. You're making sure that money is being spent with respect to our bylaws. There's an honorarium, maybe a couple hundred per audit but not sure. Any member can stand for election for the position, both 1-year and 3-year. You can nominate yourself or somebody else. After the audit, the trustees present their report to the membership, if there are recommendations coming out of it this is also shared with membership.

Mary Ellen: It just can't be an exec member.

Mary Ellen calls for 1-year trustee nominations

Mitchell self nominates

Mitchell acclaimed as 1-year trustee

No nominations received -- this will re-appear at the next GMM.

c. 4 HDLC Delegates

Mary Ellen: HDLC is the Hamilton and district labour council. These are local units associated with the Canadian Labour congress. Mostly, we share news about labour in Hamilton, and we also pass resolutions and make donations similar to the GMM. Some folks have moved on/graduated so we're filling these roles. There's no honorarium with this but it's not burdensome. It's on the 3rd Thursday of the month and hybrid. Any delegates want to add anything? Can be a member of any unit, self nominate or nominate another member.

Mary Ellen makes first call for nominations for HDLC delegates

Mitch: I want to clarify, you sent an email to everyone -- am I still a delegate?

Dams, Caleb, and Enrique are acclaimed as HDLC delegates.

d. 4 CUPE Council Voting Members

Mason: Anyone can come, but only four can vote. Good to connect with other locals.

Mary Ellen: Any questions? There's no honorarium.

Mason: They gave us food last time!

e. 5 David Saunders School participating members (April 27 to May 2, 2025) Mason: I don't see how many people are here...are we putting something in new business?

Kusum: Yes, I wanted to pass for 5 people to go to this.

Bonnie: So I wasn't sure if we needed to pass these first then pass the money?

Mary Ellen: If people are elected, then we don't pass money then people can't go.

Brad: Elections come before new business by CUPE national's rules. Weird agenda, but we have to follow it.

Mary Ellen: Everyone understands that we need to pass this then someone brings it up in new business, right?

Kusum: This is a week-long school with all sorts of trainings. Can apply to all members, exec or otherwise. Anyone who is in a union, this prepares them for action. Since our union is huge, I figured we could have 5 people.

Mason: This is April 27 to May 2 in Niagara-on-the-lake.

Mary Ellen: Same as before, the local will pay for your lodging.

Brad: It's a really good experience; would recommend staying for as much of it as you'd like.

Mary Ellen: Any questions? I'm going to open the floor.

Mary Ellen opens the floor for nominations to attend David Saunders school

Brad: For those just selected -- please send me a list of your top 3 courses. Looks like a lot of them are full. May have to get you on a waiting list, but send me those ASAP. I didn't realize how full it was.

Mason re-chaired

12. Unfinished (old) business

13. New business

a. Be it resolved that CUPE Local will institute a per-diem policy in an amount equivalent to the prevailing CUPE National per diem rate, which increases from time-to-time (See Appendix A).

Mason: This is going to be \$103 per day. Please can someone move this?

Mary Ellen: The current per diem is \$15, which is impossible. Easier to tie this to CUPE Ontario or CUPE national rates because they update it, that way we don't have to update every time.

Brad: Worth adding that a lot of conventions occur at hotels in major cities. At the Sheraton in Toronto, there aren't a lot of affordable options. This hasn't been updated since at least 2013.

Kusum moves Bonnie seconds Motion passes

b. I (Rebecca DeWael) move that the local spend up to \$100 on snacks and coffee for the Winter 2025 U1 Stewards' Network meeting.

Rand moves in Rebecca's absence Dams seconds Motion passes

c. I (Gerard Di Trolio) move that CUPE 3906 endorse Sarah Jama for Hamilton Centre MPP (See Appendix B)

Mason: Quick piece before we get into this. Any endorsement has to pass in a GMM. We can choose to endorse nobody. I put this policy out on our social media. I didn't want to go around to politicians to ask for our endorsement. I'd rather them come to us, people who care and know about us. We received 4 requests. 3 are former or current active members; they all sent blurbs in, which are in the appendix.

Gerard: I'll cut to the chase; I know many of you are involved politically. The CUPE campaign is Fire Ford, fire the boss, etc. The idea from there is that when you go to vote, you're voting as a worker. A lot of attention is being paid to Bill 124. I talked to some long term care nurses about their issues recently. We're trying to get CUPE members to vote, talk to their co-workers to get them to vote. Generally, this is for the NDP. The NDP is not perfect, but they are the best on offer considering the alternatives, Ford especially. The only other thing I'll bring up is that they were inquiring about getting member lists from all locals to call them about voting. Some locals have given them up, some are less willing. Maybe we can talk about that. We can have a discussion about this. Book-off callers, etc.

Mason: We'll have to reserve this discussion for after we've moved and seconded these motions. I don't want to give up member lists, but I like our people calling our people. Maybe you can start by moving the first motion, then we chat.

Gerard moves Mitch seconds

Mary Ellen: If you're putting things in the chat, they won't be in the minutes.

Mason: Yeah, I can't monitor the chat.

Brad: I was going to share Appendix B. Probably shared by Sarah's campaign. It's on the screen now.

Gerard: Sarah's worked tirelessly. In my life as a renter, I've been slapped with an above guideline increase, and she has been working with Acorn and other tenants in my building to fight it. She has been targeted for her positions on Gaza, and Mac should stand behind her. This is a winnable seat. It will take hard work, though.

Sarah: She's passionate about housing and disability rights, involved with Mac, and I think it would be good to endorse.

Mason: I saw Gerard canvassing the other day outside my house, she has a great team. Former strike chair for Unit 2 and former member. Would be cool to help her.

Motion passes

d. I (Gerard Di Trolio) move that CUPE 3906 endorse Kojo Damptey for Hamilton Mountain MPP (see Appendix C)

Mitch seconds

Bonnie: He's a unit 2 member, seems ready to help us with the strike and anything else.

Mason: I agree, a good guy and comes by the office regularly, will help with the strike.

Motion passes

e. I (Gerard Di Trolio) move that CUPE 3906 endorse Caleb Smolenaars for Oakville North--Burlington MPP (see Appendix D)

Dams seconds

Caleb: I don't know if it's a conflict of interest for me to speak, but I am the candidate in Oakville North-Burlington and the lead steward of unit 4. Proud to be running on a labour forward platform, I've been meeting with lots of workers, and I'm happy to be using my voice to fight back, hopefully at the provincial level.

Motion passes

f. Be it resolved that CUPE 3906 endorse Sandy Shaw for Hamilton West - Ancaster - Dundas MPP (see Appendix E)

Rand moves
Dams seconds

Rand: Sandy is the only person who isn't a former or current member of the local. She's been a friend to the local willing to engage on worker and student issues. Her last act before the election was called was to come to our drop in social which I think is cool. She's an incumbent, has been doing good work for the riding, and deserves our endorsement.

Motion passes

Rand chaired

g. I (Mason Fitzpatrick) move that the local mark at least \$400 for quarterly affiliation dues to the Hamilton District CUPE Council

Mitch seconds

Mason: I'll set aside at least \$400 for this. We already have CUPE council in our bylaws, just need to pay our dues.

Motion passes

Mason re-charied

**New Motions

Kusum: I move that CUPE 3906 send 5 people including costs to David Sauders.

Mason: Do we have a cost estimate?

Kusum: Not quite yet.

Dams seconds

Mitch: Registration is \$2100 for the school, so \$8400 plus accommodations, closer to \$10K?

Brad: My understanding is that it's an all-in cost, with lodging included.

Motion passes (costs to send 5 delegates to David Saunders School)

Kusum: Usually 10 members are sent, but I think that we could send all 7 members to CUPE Ontario. I move to send all 7 delegates who ran.

Dams seconds

Mason: Will we still have to do an election?

Mary Ellen: Point of order - the thing is, if other people had known we'd have more positions, then other people would have had a chance to step forward. Otherwise, it is not fair to people.

Mason: I know elections have passed, but can we do a second call for nominations? No, just in elections... You may have to move that we elect two additional candidates at the next GMM.

Kusum: Quick question, so what happens if we pass 7?

Mason: If we change the number after doing all this, we have to give the whole membership a chance, so I think we can only do this by adding more members next meeting.

Mitchell. We have time to register; we can do more next time.

Kusum: So what happens now?

Mason: We can amend or I can call out of order.

Kusum: I amend the motion that we send 10 people total to CUPE Ontario conference, with the election taking place first and then the 5 more added next meeting.

Dams seconds

Kusum: With lots of folks in Toronto, these costs will go down as well.

Amendment passes

Amended motion passes (Sending 10 total delegates to CUPE Ontario conference, 5 to be elected at the next GMM).

14. Other business

Gerard: I want to add a discussion about call lists and see what people's feelings are. Are we going to share this list or call people ourselves?

Kusum: Should the motion go first or share what I think?

Gerard: I move that we give our membership list to CUPE Ontario to make phone calls to our member for the provincial election.

Mitchell seconds

Gerard: They won't use them for anything else.

Kusum: I think this would help us with the access to our members. There are a lot of members who may not think alike. We don't know which person supports which party. I think we have to think about a holistic approach. CUPE is very careful about it, but we really have to take it to the GMM next time. If this backfires, we may be perceived as going for one particular party, which should be a larger discussion.

Mitch: I guess I don't know why we wouldn't want to give them the list. I think that it's just to encourage people to vote more than anything, other than opposing Ford.

Kusum: I understand, but there are some many members who may not think alike. We shouldn't revoke our support, it is just meant to understand all members' concerns.

Mason: I don't love the idea of sharing our full membership list, but would be super happy to call through the list ourselves. I'd give it to you, Gerard! It's a good chance to re-invigorate the PAC.

Gerard: Obviously, we've endorsed candidates, it is a good chance to say "go out and vote".

Mason: We'll email folks letting them know we endorsed these people. We don't want to cede control over who we've supported to CUPE Ontario.

Gerard: I can talk to other CUPE members and say "you should endorse this candidate" but I can't go to people in the street and say that. Communication within membership is legal.

Kusum: I'm worried about members who may not react well. There may be members who are passionate about other candidates, we don't want to polarize. I think encouragement to vote is good.

Mason: I appreciate that. Phone canvassing is mostly about asking who they want to vote for and reporting that. Sometimes convincing people, but mostly having a conversation, and it's good to build those skills.

Gerard: I will amend my motion to keep it all internal so that we strike a team/committee to call our own members and encourage them to vote.

Mason: A committee requires more, maybe you just want to mobilize them?

Gerard: I amend to move that CUPE 3906 mobilize our members to vote for the candidates they've endorsed.

Mitch seconds

Amendment passes

Amended motion passes that CUPE 3906 mobilize our members to vote for the candidates they've endorsed.

15. Good of the Union

Mason: The Office of sexual violence prevention has basically been cleared out-- something sketchy is happening.

Kusum: Two people were fired. There are staff members that have come together, and we're speaking at senate, there is a rally happening as well. At the open senate session, anyone can come. We're not sure why they were fired, they were doing great work and we're going to advocate for them.

Mason: Wednesday at noon is the rally. Please go if you can!

Mary Ellen: Worth saying that we're having our AGM coming up soon. All positions are up for election. You can still run from the floor, but you can nominate via form as well so keep an eye out for that.

Appendices

Appendix A:

At present, the CUPE National per diem rate is \$102 (per day). The Local policy is designed to cover meal expenses at an amount equivalent to the CUPE National rate, but, unlike the Naitonal policy, is broken down over three meals. With the \$102 per diem allowance, meals are broken down as follows: \$24 for breakfast, \$31 for lunch, and \$47 for dinner. A per diem is calculated for the full \$102 on a day when someone approved to attend business needs to purchase three meals. If, however, one meal was provided (ie/ lunch), that person must subtract that amount (ie/\$31) from the day in question. A partial day (ie/ the final day) would include only those meals that the member needed to purchase (ie/ being home by 3 pm on the last deal likely means a dinner wasn't necessary). If three meals are provided, a member on approved business may then claim only up to \$15 for incidental snacks to allow flexibility in timing of when they eat. Receipts are not required for the per diem. The daily per diem rate (currently \$102) currently reflects the CUPE National rate. If increases to the CUPE National per diem rate are made, Local 3906 will increase to the same amount and the executive committee will determine a revised per meal breakdown. In the event that a member has a dietary restrictions or a religious or cultural practice that might deviate from a typical breakfast-lunch-dinner breakdown, they should inform the treasurer who can arrange a more inclusive breakdown, but in an amount that will not exceed the daily maximum allowance.

Sarah Jama is running for re-election to be the Hamilton Centre MPP.
